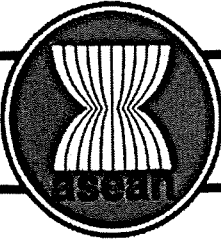

## CALL FOR APPLICATIONS

Call for applications for the 2024-2025 academic year is now open. Canadian institutions must apply online on behalf of eligible candidates by 11:59 p.m. EDT, March 21, 2024.

On August 6, 2017, the Government of Canada announced the Canada-ASEAN Scholarships and Educational Exchanges for Development (SEED) program to provide opportunities for students from ASEAN member states to conduct short-term study or research in Canadian post-secondary institutions in areas that contribute to the implementation of the [2030 Agenda for Sustainable Development](#) .

The Canada-ASEAN Scholarships and Educational Exchanges for Development program aims to reduce poverty in the developing countries of ASEAN and to achieve the [2030 Agenda for Sustainable Development](#) . Scholarships and educational exchanges will contribute towards the achievement of all [Sustainable Development Goals](#)  (SDGs). SEED contributes to strengthening people-to-people ties between Canada and the Indo-Pacific region.

SEED scholarships are facilitated through institutional collaborations and student exchange agreements between post-secondary institutions in Canada and their partner institutions in ASEAN countries.

The Canada-ASEAN Scholarships and Educational Exchanges for Development Program is a Short-term Exchange Program under Global Affairs Canada's International Scholarships Program.

### ▼ Eligibility


To be eligible, you must be:

- ✓ a citizen of an ASEAN member state
  - Brunei Darussalam, Cambodia, Indonesia, Laos (Lao People's Democratic Republic (Lao PDR)), Malaysia, Myanmar, The Philippines, Singapore, Thailand, or Vietnam
- ✓ a student enrolled full-time at a post-secondary institution in an ASEAN member state
- ✓ paying tuition fees to that institution at the time of application and for the full duration of your exchange

Students are not eligible for this scholarship if:

- you hold or have a pending application for Canadian citizenship or permanent residency
- you are already participating in a scholarship program funded by the Government of Canada
- you are already enrolled in a degree, diploma or certificate program at a Canadian post-secondary institution
- you have previously received a scholarship under the Canada-ASEAN Scholarships and Educational Exchanges for Development Program

Canadian post-secondary institutions interested in hosting students must:

- ✓ be a Designated Learning Institution  (DLI)
- ✓ have a valid student exchange agreement with the student's home institution that waives tuition fees for scholarship recipients (required for college/undergraduate study only)

### ▼ Scholarship value and duration

Award component	Value	Duration	Activities
College / undergraduate (4 months)	\$10,200	Four months or one academic term	Study or research at the college or undergraduate level. A valid student exchange agreement that waives tuition fees is required.
College / undergraduate (8 months)	\$15,900	Eight months or two academic terms	Study or research at the college or undergraduate level. A valid student exchange agreement that waives tuition fees is required.
Graduate (4 months)	\$10,200	Four months or one academic term	Study or research at the graduate level (Masters and PhD). A student exchange agreement is not required.



Award component	Value	Duration	Activities
Graduate (5-6 months)	\$12,700	Five to six months	Study or research at the graduate level (Masters and PhD). A student exchange agreement is not required.

## Eligible expenses

Selected students may use scholarship funds towards:

- ✓ visa or study/work permit fees
- ✓ airfare via the most direct and economical route
- ✓ health insurance
- ✓ living expenses, such as accommodation, utilities and food
- ✓ ground transportation, including a public transportation pass
- ✓ books and supplies required for their study or research, excluding computers and other equipment

Canadian institutions are eligible to receive:

- ✓ \$500 per scholarship recipient to aid with administrative costs once the student arrives in Canada
- ✓ reimbursement of additional employer compliance fees paid to Immigration, Refugees and Citizenship Canada in some cases

## How funding works

Canadian institutions will receive funding from Global Affairs Canada, through its legal name, the Department of Foreign Affairs, Trade and Development (DFATD) in the form of a non-negotiable contribution agreement and will be responsible for

providing the funds to successful students according to its internal processes. Should a student not take up the scholarship, Canadian institutions must return all funds, including the administrative fee, to DFATD.

### ▼ Application process

Canadian institutions must apply on behalf of eligible students before the deadline.

### Before the application period

Canadian institutions interested in hosting students should:

- ✓ promote the scholarship to faculty and staff members
- ✓ promote the scholarship to eligible partner institutions
- ✓ explore student exchange agreements with eligible partner institutions

Non-Canadian institutions interested in sending students to Canada should:

- ✓ review eligibility requirements
- ✓ explore student exchange agreements with Canadian institutions
- ✓ promote this scholarship to students
- ✓ identify students who meet the eligibility and admission requirements for the Canadian partner institution

Students interested in studying in Canada under this scholarship should:

- ✓ review the eligibility requirements
- ✓ ask your international office if your school has an exchange agreement with a Canadian post-secondary institution



✓ contact your international office to learn more about the application process and any admission requirements for the Canadian institution

## Application instructions

Application instructions for Canadian institutions applying on behalf of eligible students

1. Assign a program coordinator to complete applications.
2. [Login or Create a Momentum account](#) to apply for the scholarship on behalf of students.
3. Once you have logged into your account, select the Canada-ASEAN Scholarships and Educational Exchanges for Development (SEED) and click on “Apply Now”.
4. Enter data in the fields marked mandatory and follow instructions for each item.
5. Upload all required supporting documents. Each document must be smaller than 5 MB and in .pdf, .jpg, .doc, .docx, .txt or .gif format.
6. Verify the data prior to submission.
7. Click “SUBMIT”. You will receive a confirmation message and a reference number for submitted applications.
8. Print the form for your records using the print function in the browser.

## Scholarship selection criteria

We evaluate applications based on:

- the linkage of the proposed research or study that the student will undertake in Canada to the 2030 Agenda for

## Sustainable Development

- the candidate's commitment to use their proposed research or studies in Canada to help combat poverty and narrow the development gap in the ASEAN region
- merit of the research or study to be undertaken in Canada
- benefit to the home institution and peers
- benefit to the Canadian institution, supervisor and peers
- strength of the linkages to be created through the proposed exchange
- rankings submitted by the Canadian institution

### ▼ Key dates

## Application deadline

The deadline for Canadian institutions to submit online applications on behalf of candidates is **11:59 p.m. EDT, March 21, 2024**.

Canadian institutions should establish an earlier deadline with candidates and their home institutions to ensure timely receipt of supporting documents.

## Notification of results

The scholarship administrator will communicate successful results to Canadian institutions in the spring. The administrator will not provide feedback for unsuccessful applications.

Institutions are responsible for notifying students of successful results.

Students should contact their home institution or the Canadian institution regarding the status of their application.

## Student arrival in Canada

Selected students may arrive as early as **August 1, 2024** for the fall semester and no later than **February 1, 2025** for the winter/spring semester. Failure to arrive during this time may result in the cancellation of the scholarship.

Students should submit their visa or study/work permit application as early as possible to avoid delays.

### ▼ Scholarship conditions

## Conditions for successful students

Students selected for the scholarship agree to:

- engage in full-time studies or research as defined by the Canadian institution
- abstain from clinical training or clinically-oriented research involving direct patient-care
- focus primarily on full-time studies or research during their stay in Canada
- return to their home institutions after the scholarship period to complete their studies

Failure to meet these conditions may result in the cancellation of the scholarship.

## Additional information

- Scholarships cannot be deferred and are not renewable
- Scholarships are subject to availability of funding from the Government of Canada
- Scholarships are not taxable for either the Canadian institution or the scholarship recipient

- Students must return to their home institutions after the scholarship period to complete their studies

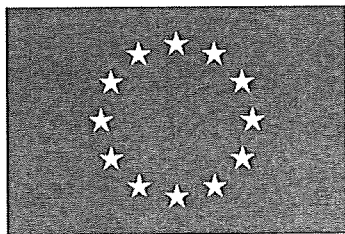

The Study in Canada Scholarships program provides students from post-secondary institutions located in the new eligible countries/territories with short-term exchange opportunities for study or research in Canadian post-secondary institutions at the college, undergraduate and graduate levels.

This student exchange program replaces the full-degree-based Study in Canada Scholarships program piloted in 2020. At least 50 scholarships will be awarded in the next competition, with the number increasing each year.

These agreements are created between colleges, technical or vocational institutes and universities. Students must be registered as full-time students in their home institution at the time of application and during the entire duration of their study or research stay in Canada.

## **Canada-ASEAN Scholarships and Educational Exchanges for Development (SEED)**

The Canada-ASEAN Scholarships and Educational Exchanges for Development (SEED) program provides students, from member states of the Association of Southeast Asian Nations (ASEAN), with short-term exchange opportunities for study or research in Canadian post-secondary institutions at the college, undergraduate and graduate levels.

### **– Eligibility**

Citizens of the following ASEAN member state are eligible: Brunei Darussalam, Cambodia, Indonesia, Laos (Lao People's Democratic Republic (Lao PDR)), Malaysia, Myanmar, The Philippines, Singapore, Thailand, or Vietnam.

Applicants must be enrolled full-time and paying tuition fees to a post-secondary school in an ASEAN member state listed above

Level of study: available to undergraduate and graduate students.

### **– Value & Duration**

- CAD 10,200 for graduate students (Master's and PhD) for a minimum of four months or one academic term of study or research;
- CAD 12,700 for graduate students (Master's and PhD) for a period of five to six months of study or research.

### **– Deadline**

01 March 2024- submission to GPS by McGill Supervisor

21 March 2024- Submission to the Government of Canada by GPS

Candidate's studies or research may commence as early as 01 August 2024 but no later than 01 February 2025.

### **– How to Apply**

Applicants are responsible for finding their own McGill Supervisor willing to supervise their research while at McGill.

Applications are submitted by GPS to CBIE on behalf of the applicant and supervisor. Supervisor is responsible for submitting all supporting documents to GPS by the indicated deadline. ### **– Required Supporting Documents**

- **Proof of citizenship:** a copy of the candidate's passport or national identity document with valid dates. Note: a driver's licence, permanent resident card, student card or baptism certificate is not accepted as proof of citizenship.
- **Proof of full-time enrolment:** a letter in English or French from the home institution, on official letterhead, dated within the last six months, confirming that the candidate is currently enrolled in a full-time program and will continue to be enrolled upon their return and providing the expected completion date of the degree. Note: copies of transcripts, a student card or letter of admission are not acceptable (maximum one page).
- **Letter of intent from the candidate:** a letter in English or French from the candidate describing the nature of their research or studies to be undertaken and explaining the rationale for study in Canada and for the choice of institution, the program and the supervisor. The candidate must also indicate how the proposed program of study or research will relate to their future career (maximum one page).
- **Letter of support from the home institution:** a letter in English or French from the candidate's instructor, professor or international director on the institution's official letterhead explaining the nature of study and how the candidate and the home institution will benefit from this scholarship program (maximum one page).
- **Letter of invitation from the Canadian supervisor:** applications for graduate students must include a letter from the Canadian supervisor indicating their willingness to support and mentor the candidate. This letter must be on institutional letterhead, be signed and demonstrate the support for the candidate during the exchange period and demonstrate how the Canadian institution, supervisor and peers will benefit (maximum one page).

For health related fields the Host Institution supervisor must confirm that the applicant is excluded from clinical training or clinically-oriented research involving direct patient-care;

- **Signed copy of Memorandum of Understanding or Agreement with the partner institution:** a written agreement or understanding, in English or in French, signed by both institutions indicating that tuition fees will not be charged and containing any other clauses of mutual interest. Note: a signed copy of this document is mandatory for undergraduate and college applications. For graduate applications, an inter-institutional agreement is desirable but not mandatory. If there is no existing exchange agreement, graduate applications which involve a new or established collaboration between professors from a Canadian institution and the candidate's home institution will be accepted.
- **Privacy Notice Statement:** a copy of the [Privacy Notice Statement for non-Canadian participants](http://www.scholarships-bourses.gc.ca/scholarships-bourses/non_can/notice-enonce.aspx?lang=eng) ([http://www.scholarships-bourses.gc.ca/scholarships-bourses/non\\_can/notice-enonce.aspx?lang=eng](http://www.scholarships-bourses.gc.ca/scholarships-bourses/non_can/notice-enonce.aspx?lang=eng)) signed by the candidate.

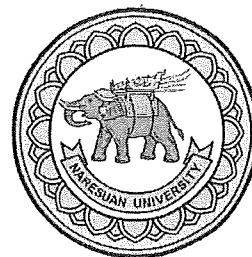

## MEMORANDUM OF UNDERSTANDING

BETWEEN THE

ROYAL INSTITUTION FOR THE ADVANCEMENT OF LEARNING /  
McGILL UNIVERSITY

AND

NARESUAN UNIVERSITY

By this letter, McGill University, Canada, and Naresuan University, THAILAND agree to cooperate with each other in order to identify potential areas of collaboration. These may include any program at either institution that could help foster and develop the relationship, such as:

1. Exchange of faculty and/or staff;
2. Joint research activities and publications;
3. Participation in seminars and academic meetings;
4. Special short-term academic programs;
5. Short and medium-term research visits for graduate students (Master's and Doctoral) and postdoctoral fellows;
6. Exchange of undergraduate students, subject to the approval process for a separate *Student Exchange Agreement*;
7. Exchange of academic and scientific materials and other information, under the umbrella of the appropriate Agreement, such as a *Material Transfer Agreement*, in conformity with the institutional policies in place.

The Parties to this *Memorandum of Understanding* agree that their collaboration on any activity, including any of the above listed activities, shall be subject to securing appropriate funding, approval of each institution's respective authorities and to entering into of separate *Agreements* upon terms and conditions mutually agreed to by the Parties. This is a non-binding agreement with the intention of facilitating collaboration between the participating institutions. All activities

are subject to the internal requirements of the Parties, and may require additional binding agreements to be entered into on a case-by-case basis.

This agreement recognizes the collaboration between the McGill Faculty of Science and Naresuan University Faculty of Social Sciences. The collaboration will be led by the Department of Geography at the McGill Faculty of Science and the Department of Sociology and Anthropology of Naresuan University. The units recognize their complementary strengths in the fields of Geography and Anthropology and wish to strengthen their relationship for the benefit of their students and researchers.

Each institution agrees not to use the other's name or logo in publicity without written consent from the authorized representative of the other institution or his/her designate.

The intellectual property policies in place at each institution shall apply to the activities initiated and implemented by the respective researchers.

Participants under this *Memorandum of Understanding* will be selected on the basis of merit without regard to race, national or ethnic origin, colour, religion, age, sex, marital status, physical handicap, or sexual orientation. Naresuan University and McGill University will each accept the participants selected by the other Party if mutually acceptable academic and/or professional qualifications and standards are met.

This *Memorandum of Understanding* shall remain in force for a period of five (5) years from the date of the last signature. Either institution may terminate their involvement with six (6) months advance written notice to the other institution.


